- **Your Payment (GST exempt)**

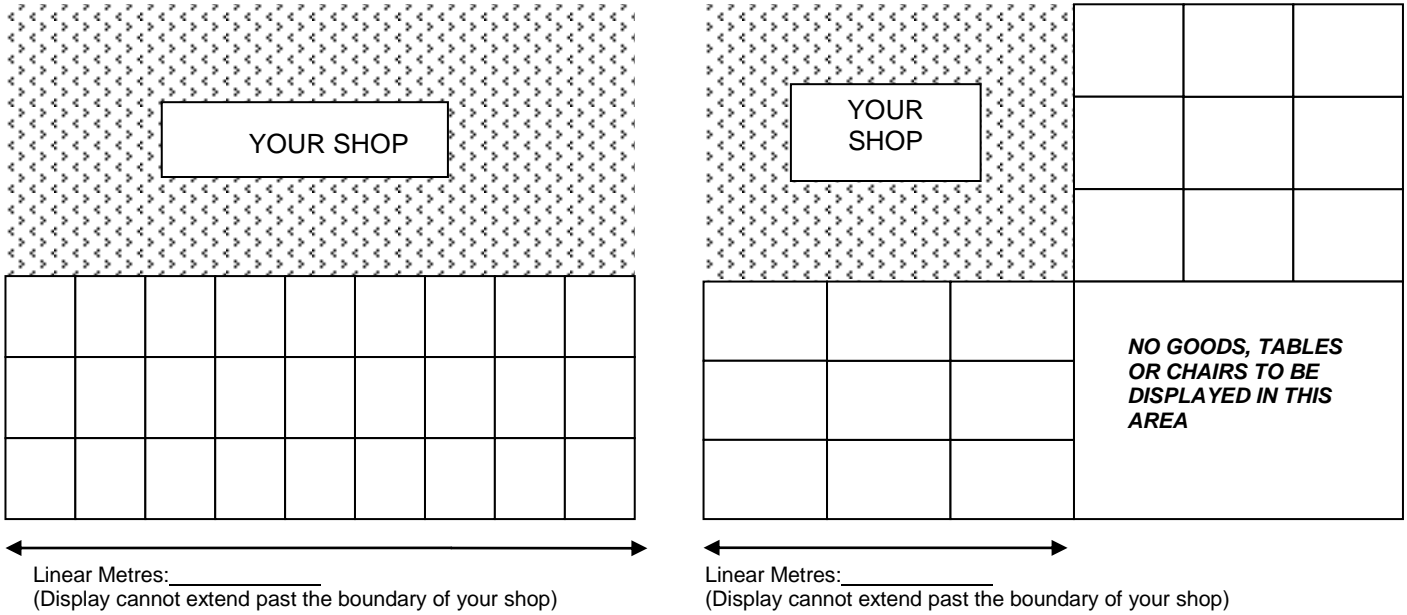
