As part of Council's commitment to sustainability and reducing food and organic waste going to landfill, limited **rebates of \$50** are offered to residents when they **spend \$50 or more** on eligible home composting products. Education providers and community groups can claim up to \$150.

## CONDITIONS

- City of Whitehorse residents, education providers or community groups are eligible to apply.
- The rebate is a one-off payment of \$50 for residents and up to \$150 for education providers for eligible products\* purchased in the previous 12 months.
- For community groups, if the purchase price of the eligible products is between \$50 and \$150 they can apply for a rebate for the full cost of the products. If the purchase price is over \$150 they can apply for a \$150 rebate.
- Claims can only be made on the products listed below and where the total value of the products is \$50 or more.
- Rebates can only be made once per household or community group.

- Copy of purchase receipt/s.
- Vendor Details Form (attached) - if not, you will receive a cheque.
- Residents: provide proof that you live in Whitehorse e.g. copy of either a rates notice, recent utility bill, driver licence etc.
