

INTRODUCTION

This register is referenced in Schedule 1 of Council's Road Management Plan.

This register is prepared in accordance with Section 17 and Schedule 1 of the Road Management Act 2004 and is a register of those roads which Council has decided are reasonably required for general public use.

The Road Hierarchy is defined in Schedule 2 of Council's Road Management Plan.

For roads which are under the control of Department of Transport and Planning (DOTP), that is freeways or arterial roads, Council is responsible for the areas outside of DOTP control. Refer to the Code of Practice "Operational Responsibility for Public Roads" (Victorian Government Gazette No S267 Friday 17 December 2004).

Unconstructed lanes and right-of-ways (R.O.W) have generally not been included in this road register. There are a number of roads, shown as roads on plans of subdivision and used by the public as roads, which are defined as 'unconstructed' roads. These roads are not included in the register. Council has a policy to construct these roads to approved standards, refer to item 12.1.7 Council meeting of 5 October 1998. Once constructed, these roads will be included in the roads register.

Council specifies the details in this register in accordance with the requirement of Road Management Act (2004), where information after 1 July 2004 is required to be recorded. Road Creation Date in the register is based on the date where Council has officially taken over the road from developer which is then considered reasonably required for general public use.

LIST OF REGISTERS

The Register contains a comprehensive list of the public roads within Whitehorse that Council has a statutory requirement to inspect, maintain and repair in accordance with our Road Management Plan.

• APPENDIX A - PUBLIC ROAD REGISTER - ROADS

This register lists the constructed roads and council access roads that are of Municipal's responsibilities under Road Management Plan.

• APPENDIX B - PUBLIC ROAD REGISTER - LANEWAYS

This register lists the constructed laneways that are of Municipal's responsibilities under Road Management Plan.

• APPENDIX C - ANCILLARY AREAS - CARPARKS

This register lists the constructed carparks that are of Municipal's responsibilities under Road Management Plan.
