

PERMANENT TREE CONTROLS

Whitehorse Planning Scheme Amendment C219

What is Amendment C219?

Council proposes to apply permanent tree protection controls across residential areas in Whitehorse via Amendment C219 to the Whitehorse Planning Scheme.

In 2016 Council undertook the Municipal Wide Tree Study to investigate the importance of vegetation, especially tree canopy, to the municipality. The Study recommended planning scheme controls to retain tree canopy and replant trees for the future. This involves applying the Significant Landscape Overlay (SLO) to all residential areas in the city that don't currently have tree protection controls.

A temporary tree protection control, Schedule 9 to the SLO (SLO9), was introduced on 8 February 2018 and is still in place until 30 June 2020 (refer to Amendments C191, C214 and C223). The temporary controls protect trees while Council progresses Amendment C219 for the permanent tree protection controls.

Amendment C219 is now on exhibition for public comment.

Where does Amendment C219 apply?

The planning controls are proposed to apply to all land included in the Neighbourhood Residential Zone, General Residential Zone, Residential Growth Zone and Low Density Residential Zone that is not already covered by a permanent SLO. The controls will not change the zoning of your land.

The Amendment proposes to apply SLO9 to land already included in the Vegetation Protection Overlay (VPO) -Schedules 1, 3 and 5 for individually significant trees. However the Amendment proposes to remove Schedules 2 and 4 to the VPO as in Mont Albert North and Mitcham South these will be duplicated by SLO9. What does Amendment C219 do?

If Amendment C219 is approved, it means that a planning permit will be needed to remove, destroy or lop a tree in areas covered by SLO9. However, a permit will not be needed for:

- A tree less than 5 metres in height **and** having a single trunk circumference of less than 1.0 metre measured at a height of 1.0 metre above ground level.
- Pruning a tree for regeneration or ornamental shaping.
- A tree that is dead, dying or has become dangerous. This needs to be checked with Council first by contacting the Planning and Building Department on 9262 6303.
- A tree that is outside the minimum building setback from the street in the Residential Growth Zone.

Amendment C219 proposes more exemptions from the need for a planning permit than the temporary controls that currently apply. These include:

- A tree that is less than 3 metres from the wall of an existing house.
- A tree that is located less than 3 metres from an in-ground swimming pool.
- A tree species that is one of the following environmental weeds: – Box Elder (Acer negundo)
 - Cape Wattle (Paraserianthes lophantha)
 - Cherry Plum (Prunus cerasifera)
 - Cootamundra Wattle (Acacia baileyana)
 - Cotoneaster (Cotoneaster spp.)
 - Desert Ash (Faxinus angustifolia)
 - Hawthorn (Crategus monoyna)
 - Mirror Bush (Coprosma angustifolia)
 - Privet (Ligustrum spp.)
 - Radiata or Monterey Pine (Pinus radiata)
 - Sallow Wattle (Acacia longifolia)
 - Sweet Pittosporum (Pittosporum undulatum)
 - Willow (Salix spp.)
- A tree on public land or in a road reserve removed by, or for, Council.
- The removal, destruction, or lopping of a tree to ensure the safe and efficient function of a utility installation such as powerlines.
- A tree that is to be removed as part of buildings or works approved in a Building Permit issued prior to 8 February 2018.
- A tree that may require separate approval to remove, destroy or lop as part of an existing planning permit.

This means that any tree that has a trunk circumference of 1.0 metre or greater measured at 1.0 metre from the ground **and/or** a height of 5 metres or greater will require a planning permit to be removed, if it doesn't meet the exemptions above.

If a permit is required, it may be possible to apply for this through the VicSmart application process, which aims to fast track decisions on minor planning applications in 10 business days. More information about VicSmart is available from http://www.whitehorse.vic.gov.au/VicSmart.html

You should contact Council to check if a permit can be applied for through this process. A report by a qualified arborist needs to be provided with planning permit applications.

The proposed tree control means that careful design and planning will be necessary to make sure that development either allows for the retention of trees that are proposed to be protected by the SLO or provides justification for their removal and allows enough space to plant new trees.

If the amendment is approved, it will allow Council to consider how a development will impact the tree canopy in the area or whether a proposal for tree removal is appropriate. The proposed tree control will also enable Council to take enforcement action if vegetation is removed without the required approval.

Ο Δήμος επιθυμεί να εφαρμόσει μόνιμους ελέγχους προστασίας των δένδρων σε κατοικημένες περιοχές στο Δήμο Whitehorse. Η Τροπολογία C219 προτείνει την προστασία δένδρων ύψους 5 μέτρων και άνω και/ή με περίμετρο κορμού ίσης ή μεγαλύτερης του 1 μέτρου σε απόσταση 1 μέτρου από το έδαφος, όπως φαίνεται στην εικόνα. Αυτό θα σημαίνει ότι θα χρειαστείτε Άδεια [Planning Permit] για να αφαιρέαετε, κόψετε ή καταστρέψετε ένα προστατειούμενο δέντρο. Παρακαλούμε σημειώσετε ότι υπάρχουν ήδη προσωρινοί έλεγχοι προστασίας των δένδρων.

Hội đồng Thành phố muốn áp dụng quy định kiểm soát bảo vệ cây lâu dài ở khắp các khu vực cư dân trong Thành phố Whitehorse. C219 Sửa đổi đề xuất bảo vệ cây cao 5 mét hoặc hơn và/hoặc có chu vi 1 mét hoặc hơn ở đoạn thân cây cách mặt đất 1 mét, như mô tả trong tranh. Điều này nghĩa là sẽ cần phải có Giấy phép Quy hoạch thì mới được nhỗ, chặt hay huỷ diệt cây được bảo vệ. Xin lưu ý là hiện giờ đã có quy định tạm thời về việc kiểm soát bảo vệ cây.

市議會希望在白馬市住宅區實施永久性樹木保護管控。依照 C219 修正案提議,高度 達5公尺以上和/或於距地面1公尺處水平量測樹幹之周長達1公尺以上的樹木(如圖 所示)將納入受保護範圍。這代表您需申請建築規劃許可方能移除、修剪或破壞受保 護樹木。請注意暫時性樹木保護管控已經實施。

Il Comune vuole applicare controlli permanenti di protezione sugli alberi in tutte le aree residenziali comunali di Whitehorse. L'emendamento C219 propone di proteggere gli alberi d'altezza uguale o superiore a 5 metri e/o con una circonferenza del tronco di 1 metro o più misurata a 1 metro dal suolo, come mostrato nella figura. Ciò significa che ci vorrà un permesso urbanistico per rimuovere, sfrondare o distruggere un albero protetto. Si prega di notare che misure temporanee di protezione degli alberi sono già in vigore.
